### 314 Lloyd Street Update

On Thursday, October 19, 314 Lloyd Street received the very crucial approval by the Board of Zoning Appeals of a Special Exception to allow Professional Offices under its newly rezoned designation of RM2, multifamily residential. As you are aware, Scott Johnston & Pat Dilger, the proposed owners/developers of this property, plan to incorporate residential and commercial office space and utilize a large portion of the office space to house their own professional architectural and design businesses.

There are several steps, including approval by the Design & Preservation Commission and City Council and obtaining various permits and easements, which must precede the occupancy of the building. However, Johnston and Dilger are very optimistic about their pending move to our neighborhood. They hope to receive a temporary occupancy permit in order to begin operations at 314 Lloyd Street by January 1, 2007.

## Butler Avenue Traffic Calming Update



The SC Department of Transportation approved our permit for the construction of two median islands on Butler Avenue, plus a limited number of parking spaces in front of the town-

houses, as voted by the neighborhood last winter. However, the islands cannot be constructed until the replacement of a Greenville Water System water line is completed (see map for details of water line project). The 42-inch water main goes from the intersection of Butler and Hampton, along

Butler to Asbury, along Asbury to Hudson, along Hudson to Markley, and then along Markley to Rhett.

According to Mike Sharpless, the manager for this project, the schedule calls for water line construction beginning in May 2007 and completing in March 2008. As part of the project, Butler Avenue will close to through traffic for several months. The neighborhood will receive more information after the bidding process begins in the spring.

#### Hats Off!!

... to the City of Greenville Public Works Department for repairing approximately 900 feet of sidewalks on Butler Avenue. According to Tim Guerin, Streets & Sidewalks Supervisor, his crews have also installed 5 handicap accessible ramps and repaired 7 driveway aprons. The City has identified several smaller side-

walk repair jobs they will complete after January 1, 2007. A big "thanks' from those of us with strollers, small toddling feet, tricycles and just those of us who can't pick our feet up as high as we used to!!

### **Community Safety**

David Carter and Larry Boyd are co-chairing our Community Safety Committee. They will work on reinstating the "Crime Watch", as well as working on an emergency plan, coordinating our efforts with the City Community Patrol Officer, and helping to identify unsafe acts/conditions within our neighborhood. 
## Potential New Home to be added to HP Neighborhood

# The Why, When, & How of Pruning



- Enhance/encourage new growth or natural shape
- Remove dead, damaged, or diseased branches
- Encourage blooming or setting fruit
- Reduce size
- Train to a certain size or shape or growth habit
- Remove branches that grow inward, downward, or rub together
- Remove suckers and watersprouts
- Remove limbs with narrow angles as they may form a weak crotch
- Select the best-spaced branches as permanent ones (spaced 6-24" apart); use thinning cuts on others
- When to prune?

<u>Spring-flowering plants (flower before June 1)</u> set flower buds in fall and bloom on previous year's growth. Prune within one month of blooming (e.g., dogwood).

<u>Summer-flowering plants</u> (flower after June 1) set flower buds in spring and bloom on new year's growth. Prune just before spring growth begins (e.g., crapemyrtle- However, **do not commit "crepe murder,"** the excessive pruning of crepe myrtle trees. Note that the crepe myrtles planted between the sidewalks and the street are City trees and should be left to the care of the City to ensure uniform canopies and the continued beautification of our neighborhood. )

<u>Non-flowering ornamentals</u> can be pruned in late winter, spring or summer. If they are pruned in fall or early winter, new growth will be encouraged, making them susceptible to cold damage because they did not have time to harden off.

<u>Trees that bleed</u> (in other words, sap runs from pruning wounds in late spring) should be pruned after leaves mature or fall to reduce bleeding, ideally in No-



vember or December (e.g., birch, maple, walnut, elm). Sap excretion is not harmful but may be unsightly; wash off the sap with a strong stream of water.

#### What are the various techniques?

The science: Terminal bud produces auxin, a hormone that directs growth of lateral buds. When a terminal bud is cut off, auxin is released and lateral buds/shoots below the cut grow vigorously.

**1. Heading back** is indiscriminately cutting off the ends of twigs. Avoid this practice because it encourages thick, dense growth at the canopy, which means the foliage within becomes sparse and the plant top heavy.

**2. Drop crotching** is pruning back to a fork where there is a branch at least half of the diameter of the limb being removed, making the angle of the crotch wider.

3. Hat racking is cutting all branches to an arbitrary length. Avoid this practice.

4. Thinning is cutting select branches back to a lateral branch or main trunk. It is the best method of pruning because it encourages new growth in the interior, reduces size, and provides a fuller plant. Thin to remove suckers and limbs that are rubbing, crossed, diseased, or dead. Also thin to take select branches (such as long or old ones) back to another lateral branch or main trunk (a higher concentration of hormones at the lateral branch/trunk causes a wound to heal more rapidly).

Notes: When pruning back to a bud, cut at a slight angle 1/2" just above a bud located to the outside of the plant. (A sharp angle produces a larger wound, whereas a flat cut does not allow water to drain.)

When removing large tree branches:

Cut the underside of the branch 15" out from the trunk and up until just before the saw binds.

Cut downward from the top 18" out from the trunk, causing the limb to split cleanly.

Begin the final cut just outside of the bark ridge (the rough, dark ridge on top of the branch at the trunk) and at an angle out, ending just outside of the bark collar (the swollen area at base of branch). The ridge/collar act as a natural barrier to decay-causing organisms. (Wound dressings do not prevent decay.)

What is skirting? Answer: Lifting the canopy by removing low-growing branches. It is best to do in late winter, before spring growth emerges. Remove lateral branches < 4 feet from ground and inwardgrowing, crossing branches. For a one-year-old plant, select one to three vigorous branches, and prune the others to the ground.

Do all trees need to be pruned? No. Broad-

*leaf evergreen trees* need very little pruning as they are naturally symmetrical (e.g., magnolia, hollies). Conifers also require little pruning. Avoid cutting hardened older wood as it will not grow back (e.g., pine, spruce).
